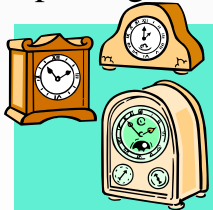

## Synopsis of the September 17, 2011 meeting

Hunter and Shannon opened the meeting and welcomed everyone back. Merrilee gave the ASL, subbing for Vicki. She taught words relating to fall/Halloween; concluding with a funny skit with Colleen.

A quote of the month will be read by our volunteer, Mary. This month's quote, "Everyone thinks his sack is heaviest." George Herbert.

Carol Blowers accepted a certificate from Linda, honoring her hard work as V/P and President. Carol accepted it with thanks.

Judi, new V/P, brought attention to our need to support the Hearing Aid Tax Credit, which can be done by contacting senators and representatives.

The DDHS, a state program, offers free seminars in St. Paul. They are free, captioned, and flyers were available on the table.

Judi spoke on "Elsies' Wish-Update". She refreshed the group on how the advocacy began, with a desire to spread the word of the needs of the deaf and HOH. Initial plans called for covering many areas, and has since been scaled down to eldercare and churches. She formed a volunteer team to assist her as needed. The team includes a research data person, clerical assistant, business assistant, spiritual support and senior web coordinator.

After interviewing at numerous care facilities, one hospice, and six churches, it became very evident that there is much that is to be done. Future plans call for a fundraiser in the coming year, in the form of a book of poetry, penned by her late husband Jerry. Combined with good publicity and hoped for inclusion in Readers Digest and/or Women's World this could provide necessary funding.

Discussion was had on the problems in church settings, and also how it would be funded. These issues are on the agenda of upcoming E.W. meetings. Lisa suggested that CART is work and maybe getting workers becomes an issue. She said we could all look to our own churches to put the word out. Put up a bulletin, ask leadership if there is a court reporter in the church who would volunteer.

Kristi, Paradigms newest addition, was introduced and received warmly.

Monique commented on how we are very badly represented, and that we need to speak up for what we need. The importance of networking was emphasized. She also suggested a need for better organization to work on furthering our cause and meet needs. She mentioned her work with MCDH concerning airport accessibility. November will end her two, three year stints on the commission.

Bob presented the treasurers report, stating that dues come up in September each year; \$25 for individuals, \$10 for newsletter only. He also said there is a Monique Hammond Endowment Fund set up for special cases.

Carol commented on the Walk for Hearing October 1. Bob and she covered the need for help, and parking and other essentials. Lisa had a closing comment, "Start asking for stuff--if they say no, ask again..and again. Keep pushing, don't get discouraged. 'The squeaky wheel gets the grease.' She noted that Paradigm captions the Gopher football games at TCF stadium

Our next meeting is October 15th and will feature Dave Vlaustin of Quality Hearing Systems speaking on "The Buzz on Bluetooth".

Hunter adjourned the meeting.

The day started off at 7 AM very chilly, and the construction people were late by 45 mins. After they set things up, we rocked. The rest of the day was decently warm for Oct. and the day flew by.

We had lots of things to keep the kiddies interested like; face painters, clowns, balloon bracelet makers and hundreds of dogs, both those belonging to the walkers and the usual doggie lake walkers.

We were exceptionally well treated by; Costco who provided bottled water, fruit snacks, granola bars, juice boxes, boxes of bananas and cookies. Berry Coffee provided coffee, cream, sugar, cups, stir sticks and the vials that kept the coffee hot. Starkey provided a hot dog stand, and a photographer.
