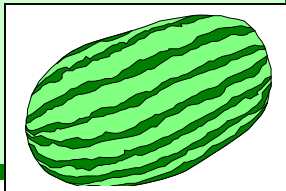

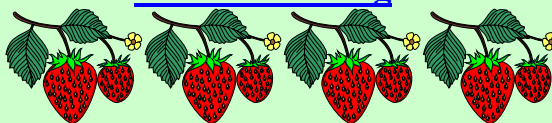

Our speaker was Mr. John Kuzak. He is from the FCC or Federal Communications Commission. He informed us that by February 17, 2009, full power TV stations will only broadcast in digital TV formats. In other words, if you are receiving free over the air analog TV (through a open rooftop antenna or rabbit ears), you must take action before that date. You have three choices-connect your analog TV to digital converter box, buy a digital television or subscribe to pay TV services such as cable or satellite TV. For more information go to (www.dtv2009.gov). As for captioning, the FCC requires that all converter boxes pass through the existing Closed Captioning signals. This is a function of your TV set. TV's manufactured after 1993 have to have the ability to display Closed Captioning. Thank you John for sharing your knowledge with us. It has cleared up much confusion!

Congratulations to Secretary Sue's daughter, Kathy, who was inducted in the International Nurses Honor Society. We missed you Sue, but also celebrated with you. Today, we also wished Ross Hammond a Happy Birthday.

Airlines Face New Government Mandates

The federal government is requiring airlines to better accommodate passengers with breathing, hearing and vision problems.

The U.S. Department of Transportation has issued new mandates telling airlines to include easy-to-read captions on safety videos and flight information in terminals and on aircraft to accommodate deaf passengers.

The DOT rules also tells airlines to better accommodate passengers with breathing problems who require oxygen tanks.

The mandates go into effect next year.

The Air Transport Association (an industry group representing airlines) said it is reviewing the new requirements.

The Transportation Department also is considering additional rules, including requiring airlines to provide oxygen to passengers with breathing problems upon request and requiring closed captioning and other accessibility elements for on-plane entertainment systems, airline Web sites and ticket kiosks.

The government actions come as airlines struggle with high fuel costs. US Airways Group Inc. (NYSE: LCC) lost \$236 million during the first quarter. The Tempe-based carrier saw its first-quarter fuel expenses come in at \$823 million, a 50 percent jump from a year earlier.

Help from CaptionsON VRB

CaptionsON Viewer Relations Bureau (VRB) can help you submit your captioning feedback and present it to those that CAN do something (such as the FCC).

The diagram below shows how captioning is delivered for most television programs. Faults can happen anywhere along this chain. The Viewer Relations bureau will walk you through steps to help determine where the problem occurs.



Television Captioning Distribution Chain

Note: Our VRB is currently designed for television programming only. The VRB will include other media (Internet, iPods, mobile video) as they become accessible.

You should anticipate the following qualities in your captioning:

1. Your program is captioned from start to finish
2. The sentences make sense – the text mirrors what the speaker is saying
3. Words are spelled correctly
4. Captions are grammatically correct
5. Captions are referring to specifics - names and places (i.e. the name of a river instead of just “river”)
6. You can tell when the speaker has changed
7. The captions do not interfere with other displayed text

Common technical errors include:

A string of symbols and/or boxes in place of words

An excessive delay (you are waiting for the next series of sentences longer than usual) in the delivery of the captioning

Captioning changes in appearance - appears to drop to the bottom of your screen, the colors change, words are underscored. If you are having any problems with captioning, first check your television. If the same problem occurs on more than one channel, the problem may be your set. After checking your television, contact your cable company and the network on which you're having a problem.

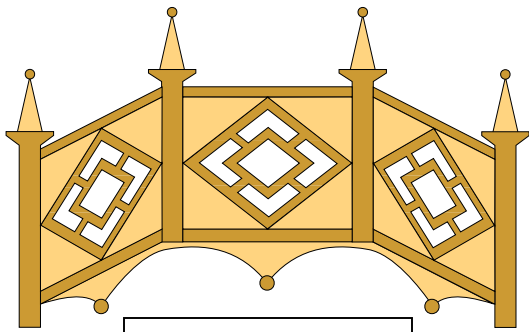

Dizziness or Vertigo?

From Delray/Boynton FL Chapter

It is estimated that 76 million Americans will have vertigo in their lifetime. Balance related falls cause 250,000 hip fractures a yr. In people over 65. Balance can affect a person's ability to stand, walk, see clearly, read, watch TV and think

Symptoms include feelings of lightheadedness, loss of balance, spinning sensations or unsteadiness of gait. The cause may be an inner ear disorder, which can occur even without hearing loss.

Diagnosing Vertigo: To evaluate the function of the balance system, physicians can request (ENG) testing Electronystagmography or Auditory Brainstem Response testing (ABR). This series of tests is not painful or demanding. Your physician must order these tests.

Captions vs Megayacht

A massive retirement community in FL called the **Villages**, which houses over 70, 000, is not complying with the FCC's mandate that their local TV programs be captioned for the 33, 000 who live there who are Deaf or HOH. The "news" events include things of importance to the elderly like golf events, church events, spots events, community mtgs., closings, emergencies, weather alerts, Village events etc. etc. I guess those are things of importance to the hearing world only right?

They also claim to be 100% accessible to all their tenants.

The Villages owner says it's too expensive. Lets see now, they can afford 3 corporate jets and a single engine airplane, paying its pilots, maintenance and fuel. It chauffeurs VIP's and lays out \$137, 515 annually for US customs agents to staff the airport so passengers aboard don't have to clear customs. Then there is the Dutch built 147 ft. megayacht registered in the Cayman Islands. Lets see to fill one jet at \$5.19 a gallon it takes \$12, 362. Since Jan. of this yr. one jet has made 95 trips. Do think they could give up one trip to the Bahamas to put in closed captions for one year? NOPE

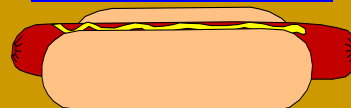

Reveal the Iceberg

A huge potential of members and advocates exists in the boomers and other seniors who are gradually losing their hearing.

HLAA is about self-help. We feel some pride in being able to function as well as we do, with the degree of hearing loss we have.

We need to realize that, if we are ever going to mobilize the whole population of hard of hearing people, we must address the fact that, a large majority of them, like an iceberg are hidden. We need to find ways to get them out in the open.

This past weekend I attended a conference. My cochlear implant made it possible for me to get most of the information. Still, it was a study in the necessity of advocacy. From requesting a repeat of the questions to suggesting that the presenter actually use the closed captioning which was written right there on the DVD.

While Roald and I were taking a breather, we began a conversation with a woman looking over the book sales area. We introduced ourselves. I said, I'm the one that was asking for the repeat of questions.

And she said, "Oh, I remember. I have a hearing loss in both ears too." She had noticed that the presenter kind of blew me off.

As we continued the discussion, it became apparent that, even though she knew she had a hearing loss and found it difficult to hear in noisy situations, she had not even looked into hearing aids. The classic statement is "I get along all right."

But if you don't hear, you don't know what you don't hear!

As we continued, I commented that the presenter had obviously thought I was the only person with a hearing loss in the auditorium (because I was the only one who spoke up), she said, "I guess you're right. I should speak up. And I'm going to look into hearing aids and a cochlear implant.

For her, it took just a little nudge. But many people, it's not just that they don't want to admit their hearing loss. Or that they feel inertia and decide not to ask for help.

Some of them just don't know. It's come on so gradually. All they know is life isn't much fun any more. They laugh less. They figure they're just getting old.

When they finally know, there's another brand of inertia. They're tired.

What's my point?

Self help aside, if we advocate for them and build in access for them, they begin to realize there *is* life after a hearing loss. They may begin to advocate for themselves.

Brainstorm! Get them to a presentation. Make sure they can hear every word – and then – remove the CART or whatever else has been helping them. They may realize that there are ways to rejoin the world.

What else can you try? How can you help them?

That's my mission – to help them know how good life can be. I know it's yours too.

Pay Pals in trouble with the NAD

A few months ago a deaf patron placed a call to order some merchandise via the relay system. It went via Pay Pal to the employees in India who were not aware of a third party system being on the line and a part of the transaction. The customer was treated rudely; a complaint was filed with NAD (National Association of the Deaf) in Washington, DC. Pay Pal was made aware of what happened, apologized and said they would make sure employees were trained in the future to handle relay calls.

It is illegal to both manufacture and purchase pirated DVDs. As a consumer, purchasing a DVD through unlicensed vendors is not only against the law, it hurts films and filmmakers.

The film will be released for institutional distribution (universities, schools, research and medical centers) in June 2008 and released for Home Video purchase and rental in early 2009. 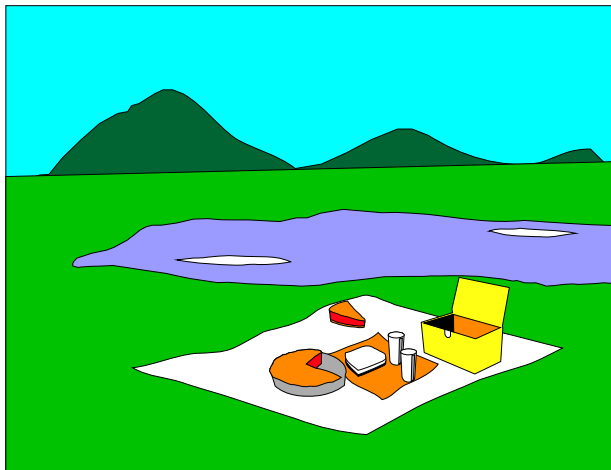
