

# HLAA-TC March 19, 2016 Meeting Synopsis

President Christine Morgan called the meeting to order at 10 AM. She welcomed all those in attendance, announced a new drawing for the remaining hearing enhancement training package (LACE) and announced the quote for the day from the Dalai Lama about practicing compassion. Vice President Lionel Locke then introduced our speaker Mr. Brent Lucas, CEO of Envoy Medical. A licensed attorney with a passion for medical devices and the hearing industry, Brent explained Envoy Medical's Esteem hearing implant to our group.

After reviewing hearing loss as a general topic, Mr. Lucas explained that the Esteem implant uses the human ear and the eardrum as the sound pickup for the implant. There is no actual manufactured microphone; the implant leverages the natural ear canal without blockage to serve as the conduit for the sound waves to reach the implant's sensor.

The Esteem implant is designed for moderate to severe sensorineural hearing loss from 40 to 90 decibels; therefore not all people with hearing loss fit the parameters of this medical device. This device is considered a middle ear implant; first created by an audiologist trying to solve the feedback problem of hearing aids. The device is analog rather than digital allowing for a full spectrum of sound with a goal of reducing feedback, whistling and occlusion (defined as sound waves not moving directly but around obstacles).

Brent then delivered a brief history of his company Envoy Medical formally called St. Croix Medical and the difficult route they had taken to earn FDA approval of the Esteem Device, achieving that milestone in 2010. They celebrated 6 years of approval for their device on St. Patrick's Day.

With no external components, the *Esteem* implant sits in the mastoid cavity, has a battery that last 5 years on average and then has two sensors, one receiving the vibration of sound waves next to the incus bone and the second sending those signals to the auditory nerve by way of the cochlea.

Brent answered a number of questions from the audience including how to replace the battery, (another outpatient surgery), how the sound quality compares to other implants (more natural according to some) because the sound is coming through the eardrum and the ear canal. This implant is another option for those

people who may not be able to use traditional amplification products even though it is not covered by insurance.

Mr. Lucas ended his presentation by talking about how technology continues to evolve and that his company is looking at rechargeable versions for the battery pack, as well as the learning curve before activation of the device. Cost of the device was one of the last questions asked and answered. Brent concluded his remarks by announcing that 1,000 devices have been implanted and only one clinic in Minnesota does this surgery.

After the break President Christine Morgan asked the membership to complete a survey from the State Telephone Equipment Distribution program asking if the program is meeting current needs and is ready to meet future needs.

Editor Vicki Martin introduced the monthly ASL lesson this one about spring including onward and upward words. The officers delivered their reports followed by open forum time. Discussion centered around television captioning issues, current legislative actions both federal and state wide and the upcoming HLAA convention to be held in Washington DC in June.

President Morgan invited any members to attend the Board of Directors meeting to be held after adjournment. She thanked all those in attendance and the meeting adjourned at Noon.



**Julia Biedenstein**, MS, LSLS Cert. AVEd, is a Cochlear Implant Consumer Specialist with Advanced Bionics. Prior to coming to AB, she worked in the field of deaf education for 35 years serving as a classroom teacher and school administrator at Central Institute for the Deaf and the Moog Center for Deaf Education, and as a researcher at Washington University. She has lectured extensively throughout the US and has co-authored 3 widely used curricula for deaf children: *SPICE: Speech Perception Instructional Curriculum and Evaluation*; *TASL: Teacher Assessment of Spoken Language*; and *Teaching Activities for Children Who are Deaf and Hard of Hearing*.

**Jennifer Brown**, MS, JD, joined Cochlear in September 2013, and serves as the Area Manager for the Northern Plains Territory. Jennifer received her BS degree with a double major in Communication Disorders and Political Science from the University of Wisconsin - Madison in 1998, her MS degree in Speech and Hearing Science from Washington University in St. Louis in 2000, and her JD from DePaul University College of Law in 2006. Prior to joining Cochlear, Jennifer was a cochlear implant audiologist in New York City and Chicago, and was a practicing attorney in private practice for seven years.

**Christine Pett**, M.S. Speech & Hearing, is a certified Deaf Educator who has previously taught listening and spoken language to deaf and hard of hearing children (PreK-12) for twelve years in St. Louis, MO as well as in Phoenix, AZ. Christine became a Consumer Outreach Manager for MED-EL in 2010. She travels extensively throughout the Midwest to support educators, SLP's, educational audiologists, parents of deaf children and adult consumers. Christine educates others on MED-EL's cochlear implant technology and middle ear implant technology as well as MED-EL's many educational and aural rehab support services. She is the mother of a (grown) son who has been wearing a cochlear implant for 14 years.


# How to find us!

Get out your magnifying glass, and check out these maps, furnished and annotated by Treasurer Marie!




The Walk funds are totally separate from the HLAA Twin Cities bank account. The Walk Chair is available to provide guidance and help along the way.




This request for gathering anecdotes from those with a hearing loss comes from ASL Interpreting Services (ASLIS).
